GUIDANCE NOTES

Complete Section 1 and the appropriate Sections of this forms as indicated in Section 2 - Nature of Interest in the Aircraft.

If the aircraft for which a REPUBLIC OF VANUATU Registration is sought is, or has been previously entered in the Register of a country other than VANUATU, you must arrange for the appropriate authority of that country to notify the Director that the aircraft has been removed from the Register of such country. The notification must give the aircraft's former nationality and registration marks and also identify the aircraft by make, model and serial number. This de-registration notification must be received by the Director before the REPUBLIC OF VANUATU Registration will be granted.

An aircraft previously granted a REPUBLIC of VANUATU Registration will assume its former assigned registration mark when again presented for registration.

Where two or more persons who, jointly or in common, hold any of the interest of the nature specified in Section 2 - Nature of Interest in the Aircraft held by the Applicant, the name and address of their nominee as declared in Section 6 - Joint Ownership Details, are to be entered as either the owner, purchaser under a hire-purchase agreement, or hirer or chartered, whenever appearing on this form.

If you are acquiring the aircraft under a hire purchase agreement or a contract of hire or charter, the name and address of the person holding the title to the aircraft is to be entered in Section 3 - Ownership Details Under these circumstances your name and address should be entered in either Section 4 - Hirer Purchase Agreement Details, or at Section 5 - Hire or Charter Details.

Where the applicant is a private, public or proprietary company duly registered as a corporation in the REPUBLIC of VANUATU, the Public Officer of the corporation must sign the form in Section 8 - Declaration.

If you are making application an application on behalf of another person you must attach a copy of his written authorization for you to act as his agent.

If the aircraft is at present located overseas and it is desired that it be flown to the REPUBLIC of VANUATU as a REPUBLIC of VANUATU aircraft, this form should be lodged with the Authority at least six (6) weeks in advance of the anticipated date of acquisition of the aircraft.
